Authority Vice Chair Cole moved and Authority Chari Bradish seconded to close the public hearing and that a resolution of the Littleton Licensing Authority be approved which grants Rancho La Playa LLC, d/b/a 3 Potrillos Mexican Restaurant & Taqueria, 3625 West Bowles Avenue #16, Littleton, Colorado, a hotel and restaurant liquor license contingent upon approval by the Colorado Liquor Enforcement Division and based upon the following findings of fact: (1) that notice of the hearing was properly posted and published; (2) that the applicant has possession of the premises and the premises are suitable for the requested license; (3) that the needs of the neighborhood are not now being met; (4) that it is the desire of the adult inhabitants of the neighborhood that the license be issued; (5) that existing similar liquor licenses in the designated neighborhood are not adequate; and (6) that the applicant and registered manager are persons of good moral character, record and reputation.

Based on said findings, I move that a public hearing be set for January 14, 2015, for the purpose of considering the status of said license, wherein the above-mentioned licensee may be present to show cause, if any, why its license should not be suspended or revoked, and further that notice of these findings and the hearing to show cause shall be forwarded and served to Vasilios Frangiskakis, d/b/a Old Mill Brewery, 5798 South Rapp Street, Littleton, Colorado, in accordance with the provisions of state law.
