Authority Chairperson Gallagher stated this hearing was for a Probable Cause determination on Police report #2010000426, dated January 22, 2010.

Authority Member Gallagher stated that the licensee has been before the board before and at the last hearing, Mr. Ghebremedhin said he would not be working in the store. He stated that there is a regulation that allows a temporary suspension and scheduling a public hearing for the show cause hearing, feels that action should be taken tonight, and bring the licensee in for a hearing within 15 days.

Kelly Piets, Esquire Petitioning, Ms. Piets explained the petitioning process. The petitioners completed 642 doorknocks, with 196 residents and 39 business owners in support of issuance of the license, for a total of 239. This is 98% in favor of the license. There were four persons who signed in opposition.

Francis Schultz, President, addressed the Authority. Mr. Schultz addressed Exhibit G, explaining the business and location to the Authority. He explained the liquor serving policy of the business and stated that all staff will be TIPS trained and that they have never had a liquor violation at any location.

William Schallmosser, registered manager, addressed the Authority and gave his background. He has been in the restaurant business going back almost 30 years. He stated that about 2/3 of the employees will handle alcohol and all will be TIPS trained. They are planning on opening in about eight months, and are still waiting on Historic Preservation Board approval.

Attorney Beimford stated that the diagram previously submitted in the packet will be replaced with the current diagram submitted in Exhibit G.

Mr. Schultz addressed the seating capacity and patio area.

It was moved by AUTHORITY MEMBER BRADISH, seconded by AUTHORITY MEMBER COLE THAT THE PUBLIC HEARING BE CLOSED AND A RESOLUTION OF THE LITTLETON LICENSING AUTHORITY BE APPROVED WHICH GRANTS TAVERN LITTLETON INC., DOING BUSINESS AS TAVERN LITTLETON, 2589 WEST MAIN STREET, LITTLETON, COLORADO, A HOTEL & RESTAURANT LIQUOR LICENSE CONTINGENT UPON APPROVAL FROM THE COLORADO BUREAU OF INVESTIGATION AND THE COLORADO LIQUOR ENFORCEMENT DIVISION AND BASED UPON THE FOLLOWING FINDINGS OF FACT: (1) THAT THE NEEDS OF THE NEIGHBORHOOD ARE NOT NOW BEING MET; AND (2) THAT IT IS THE DESIRE OF THE ADULT INHABITANTS OF THE NEIGHBORHOOD THAT THE LICENSE BE ISSUED.

Attorney McCarthy presented the police report and alleged violation information to the Authority. She stated that the licensee would be stipulating to the sale of alcohol to three minors. The licensee has no prior violations. The stipulation is for a 3-day suspension, with 3 days held in abeyance for one year and proof of TIPS training by 4/10/10.

Emmalee Pham, licensee, addressed the Authority. She explained their policy on liquor sales.

Authority Member Gallagher asked what the licensee is going to do to prevent this from happening again.

Ms. Pham stated that after this happened, she sent a couple people in with fake IDs to see if her employee was checking and he did check and did not sell to minors. She stated that they would now have two people working during busy times. She has posted check ID signs at the cash registers. Her current store manager has 14 years experience and was the previous owner before she purchased the business.

Authority Member Bradish asked of the current status of employee that sold the alcohol.

Ms. Pham stated that he still works there stocking liquor, only works once in awhile, but always has another person there with him.

BASED ON SAID FINDINGS, I MOVE THAT CAPS LIQUOR MART LLC, DBA: CAPS LIQUOR, 5196 SOUTH LOWELL BLVD. LIQUOR LICENSE BE SUSPENDED FOR 3 DAYS WITH 3 DAYS HELD IN ABEYANCE FOR ONE YEAR AND THAT ALL EMPLOYEES BE TIPS TRAINED AND PROOF SUBMITTED BY APRIL 10, 2010.

Adam Krier, owner, and Steve Rodgers, Manager, addressed the Authority. Mr. Rodgers stated that he is the manager and works seven days a week. Ryan Pittsenbarger is a friend who he had helping on the day after Thanksgiving so he could have a day off and he was the person who sold to the minor. They have a policy to ID everyone. He stated that in

the future, anyone who works would be TIPS trained. Mr. Pittsenbarger does not work at the store any more.

Attorney McCarthy presented the police report and alleged violation information to the Authority. She stated that there was a stipulation for a 6-day suspension, to serve two days, and four days held in abeyance for one year, with proof of TIPS training for all employees by 4/10/10.

Adam Stapen, attorney, and Petra Bennett, area manager, addressed the Authority. Mr. Stapen stated that they have all the proper procedures in place, have installed POS

machines, have recurrent training for employees, and do not know what else they could do to present this from happening.

Ms. Bennett stated that the turnover in that store is less than 30%, meaning that this is low, the turnover rate at most stores is usually much higher. This store is located close to a high school, and has a consistent basis of underage people trying to buy alcohol and tobacco. Store personnel usually do a good job with checking ID. The store has received commendations from the neighborhood for checking IDs of customers. The employee that sold to the minor had worked there for three months and had two separate alcohol trainings during that time.

Christine Nelms, store manager, stated she has five employees at the store. This person was hired to fill in for vacations and only worked part-time. They were told to card everybody, unless they know them as a regular customer and have already asked for their ID.

Attorney McCarthy stated that the 2-day stipulation includes the 1 day held in abeyance from the previous violation.

Authority Members discussed the stipulation, did not agree with the penalty, and stated they would be suggesting a different penalty to involve a 3-day active suspension and 4 days held in abeyance. The licensee and attorney agreed to that stipulation.

BASED ON SAID FINDINGS, I MOVE THAT METRO OIL CO., INC., D/B/A DIAMOND SHAMROCK #1109, 6857 SOUTH BROADWAY LIQUOR LICENSE BE SUSPENDED FOR 7 DAYS, WITH 4 DAYS HELD IN ABEYANCE FOR ONE YEAR, TIPS TRAINING BY 4/10/10 AND THAT NOTICES OF SUCH SUSPENSION BE POSTED IN AND OUTSIDE OF THE LICENSED PREMISES IN ACCORDANCE WITH LIQUOR CODE REGULATION 47-600(F); AND THAT THE SUSPENSION BEGIN ON MARCH 1, 2 and 3, 2010.


b) **Authority Members** – Authority Member Gunia asked about the procedures for an emergency suspension.
